4. The Bid Security as mentioned above in shape of pay order in favour of KMC shall must be enclosed with tender documents without which the tender will be treated as cancelled.
5. The Contractor must mention their complete and correct present postal address in tender documents & quote the rates both in words in figures. Incomplete /Conditional tenders will be not accepted. In addition the bidders must furnish the documentary evidence against each eligibility criteria as mention above and minimum qualification criteria as mentioned the bidding documents. Otherwise their tender will be summarily rejected without consideration of their bid amount.
6. The successful bidder shall furnish a performance guarantee at the time of agreement in shape of Pay Order / Bank Guarantee equal to 2% of sanctioned cost. This guarantee will be released after completion of work.
7. An amount equal to 8% from each bill will be deducted as Retention Money, which will be released after successful expiry of maintenance period.
