2-The Tender Document will be issued to contractor on the submission of written request on letter head and on payment of non-refundable cost of tender price through pay order from any schedule bank in favors of District Council Karachi as mentioned above .The photo Copy of P.E.C. Registration Certificate should be enclosed with the bid otherwise the tender will be rejected .No tender will be sold on the tender opening date .

3-In case of any reason , if the tenders are not responded on the above date the next date of submission and opening will be 11-10-2012 and the tender document will be available for sale from 07-10-2012.

4-Incase the date of opening is declared as a public holiday by the government , the next official working day shall be deemed to the date for submission and opening of tenders of the same time as mentioned .
