



SHORT NOTICE TENDER

The Underground Coal Gasification Project Thar, Coal & Energy Development Department, Government of Sindh has imported Core Drilling Rig Machine from China to UCG Thar Site via Karachi Seaport at a total CFR Value **\$125,833.20**. Bid Security equivalent to 2% of the total tender price (in favor of Accounts Officer, UCG Project Thar) in the shape of Pay Order/Demand Draft must accompany the tender.

2. Consignment has to be cleared from custom authorities of Karachi Seaport. Therefore, quotations pertaining to service charges for clearance of consignment and transportation with loading/unloading of said shipment to UCG Thar Site, (42Km from Islamkot, Distt Tharparkar) Sindh is required. Weight and dimensions of the equipment is as under:-

- i. Weight: **17500Kg**
 - a) Main machine of HXY-44T drill rig with diesel engine: about 2800kgs
 - b) Drill tower: 3 sections, each about 200kgs
 - c) HQ drill rod: 8 packages, each one is about 890kgs
 - d) BW-250 mud pump: packed in one wooden case, about 600kgs
 - e) Casing: 2 packages, each one is about 1200kgs
 - f) Inner tube: 1 package, about 170kgs
 - g) Out tube: 1 package, about 550kgs
 - h) Drilling tools and spare parts are packed in small wooden cases and cartons.
