2. For each of the above works, the bid shall comprise a single package two separate envelopes inside. Each as per SPP RULES 2010 Section 46(2), envelop shall contain separately the "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL".
3. On scheduled date of bid opening, for each of the work above, only envelopes of "TECHNICAL PROPOSAL" will be opened and envelop marked "FINANCIAL PROPOSAL" will be retained in the safe custody as per SPPRA RULES 2010 Section 46(2).
4. After Technical Evaluation, envelope of "FINANCIAL PROPOSAL" of technically accepted bidders will be opened for each of the work above with prior intimation to successful bidder(s). The FINANCIAL PROPOSAL of bids found technically non-conforming will be returned unopened to the respective bidder, as per SPPRA RULES 2010 Section 46(2).
5. For each of the work above, tenders shall be received back on closing date of the tender, i.e. 27TH September, 2013 up to 2:00 P.M and opened by the Procurement Committee on the same day at 2:30 P.M, in presence of bidders or their authorized representative who wish to attend.

6. Eligibility Conditions as per SPPRA RULES 2010 Section 46(2), for tender participants are as under:-
 - a. Documentary evidence of work of supplies in progress and certificate of satisfactory completion for last three (03) years.
 - b. Registration with Income Tax Department (NTN) Certificate.
 - c. Registration with Sales Tax Department (GST) Certificate.
7. The Bidder should submit undertaking on Affidavit that firm is not involved in any litigation or abandoned any work in any department.
8. The Bidder should submit bid security @ 2% in shape of Call Deposit / Pay Order / Demand Draft prepared from any schedule bank in favor of undersigned.
9. The undersigned reserves the right to enhance / reduce the quantity without assigning any reason as per SPPRA RULES 2010 Section 16(e)(i).
10. The procuring agency shall announce the results of bid evaluation in the form of a report, giving justification for acceptance of a bid or proposal, subject to the relevant provision of SPPRA RULES Section 45.
