Karachi Fisheries Harbour Authority will conduct a public auction of following New under construction and Old Repair Boats at Karachi Fish harbor in pursuance of section (52) | chapter 7 of the Karachi Fisheries harbor Authority management & Control Registration 1992.

1. All the commercial Banks and other financial institutions and any person having any legal proceeding, liabilities against these registered under old repair and New construction boats should contact the undersigned within 07 days from the date of publication of this notice.
2. After the expiry of 07 days period the Authority shall auction these boats "as is where is basis" at the risk and cost of the boat owner and liable agency and the sale proceeds thereof shall be retained by the Authority.
3. Public auction will be conduct on 22 to 23 Oct, 2013 at 11:00 A.M in Head Office of Karachi Fisheries harbor Authority, Fish Harbour, West Wharf Road, Karachi on as is where is basis.
4. NOC will be issued to successful bidder for transfer of Kole from merchant Marine Department.
5. All successful bidder will deposit 25% of the accepted bid with auction on the fall of hammer and remaining 75% value of the lots will be deposit within next 02 days in with Habib Bank Fish Harbour Branch.
6. Successful Bidder must remove the boat within 10 days. Otherwise deposited amount will be forfeited.
7. Successful bidder should have to deposit the income tax @ 15% in case of registered firm and 18% in case of non-registered firm and produce the receipt/ challan before taking away boats.
8. All bidder are required to inspect the said old repair and new under construction boats through Director Administration & Finance for the own assessment / estimate on any working day during office hours.
9. Karachi Fisheries harbor Authority reserves the rights to accept or reject any bid without any lot without assigning any reason thereof.
10. Participation in the bid will be allowed after submission of non-refundable pay order of Rs. 25,000/= (Rupees twenty five thousand).
