2. The tenders documents will be issued to the Contractors/firms on submission of applications on their original letter head along with Challan of Tender Cost (non-refundable) in favour of K.M.C.as per eligibility conditions as mentioned above.
3. The Bid Security as mentioned above in shape of pay order in favour of K.M.C. must be enclosed with tender documents without which the tender will be treated as cancelled. The pay orders of 2nd and 3rd Lowest bidders will be returned after finalization of tender.
4. The contractors must mention their complete and correct present postal address in tender documents & quote the rates both in words & in figures. Incomplete/conditional tenders will not be accepted. The bidders must furnish the documentary evidence for eligibility as well as minimum qualification criteria as mentioned above, otherwise their tenders will be summarily rejected without consideration of their bid amount.

5. In case of un-workable rate, KMC may ask the bidder to furnish performance guarantee of an amount equal to 10% of estimated (Construction) cost as mentioned in the N.I.T. in shape of Pay Order or Bank Guarantee in favour of K.M.C. at the time of agreement, which will be released along with the Retention Money. In case of non-furnishing this additional performance guarantee, the bid security will be forfeited and other action including black listing will be taken as per rule.
6. The procuring agency may reject all or any bids at any time prior to the acceptance of a bid, subject to the relevant provision of SPPRA Rule 2010.
7. The terms and conditions of contract will also be available on K.M.C. Web Site (www.karachicity.gov.pk) which must be down loaded and be submitted with tender, otherwise tender can be rejected.
8. In case the opening date is declared as public holiday by the Government, the next working day shall be deemed to be the date for submission and opening of tender.
9. A pre-bid meeting will be held on 28th October 2013 in the office of Senior Director T&C Department, 8th Floor, Civic Centre, at 03:00 PM.
