3. Consortium consisting of more than two (02) firms will not be eligible for the participation in the prequalification procedures.


4. The firms Consultants having vast experience in supervision for construction of Small, Medium & Large Dams shall only be eligible for participation in short listing.
5. The Consultant having renewal Certificate of PEC for the year ending December 2013, with the allocation f code No. 1205 shall only be eligible for participation in short listing of Civil Engineering Consultants for proposed consultancy services.
6. The Consultants must have the latest GIS with Hydro analysis licensed software's for slope Stability Analysis, Finite Element Seepage Analysis system, FEM seismic Analysis, HEC-RAS & HEC-HMS along with its complete knowledge of operation.
