The tender documents can be obtained from Senior Engineer Civil, Underground Coal Gasification Project Thar office through application along with pay order /demand draft of Rs.2,000/- (Non Refundable) against tender documents fees in favor of Accounts Officer , Underground Coal Gasification Project Thar.

3. Only those firms which are either registered with Underground Coal Gasification Project Thar or willing to get them registered with this office are eligible to apply.

4. **Earnest Money.** Pay order/ Demand Draft in favor of Accounts Officer Underground Coal Gasification Project Thar amounting to 2% of the bid value will be submitted by the firms along with their quotation. Earnest Money of the firm will be returned after finalization of the contract.

5. **Validity of offer** should be minimum 90-120 days. Validity of offer less than 90 days may be rejected. The offer over written / without specification or received late will not be entertained.
6. Manufacturers will quote their rates directly instead of through dealers.
7. The tender will be opened in the presence of representatives of quoted firms.
8. The quantity of item can be increased or decreased.
9. No escalation in the price will be given till three months from the date of signing of contract.
10. Procuring agency "may reject all bids or proposal at any time, prior to the acceptance of a bid or proposal. However Underground Coal Gasification Project Thar shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the ground for it's rejection of bids or proposal, but is not required to justify those grounds"
