The walls are to be constructed for strengthening the security arrangements and hence completion of the works is required in minimum period so as to secure the Jail premises.

- f. Proof of valid registration with Pakistan Engineering Council for the year 2013.
- g. List of tools, plants, equipment, machinery and steel shuttering for fair finishing.
- h. List of qualified Technical and Non-Technical personnel with their Bio-Data.
- i. Financial status with proof of last one year Bank statement and last three year Tax Assessment / balance sheet from Chartered Accountants.
- j. The National Tax Number of the Firm.
- k. Certificate to the effect that the firm is not involved in litigation with any Department.
- An undertaking by the Firm / Contractor to the effect that "Neither the Firm / Contractor nor its Directors / Stakeholders, as a whole or as a part, of the company / Organization have ever been black listed / defaulted with any Government Agency / Department / Organization and also that the information supplied by the Firm / Contractor is correct".
