4. NOC from Excise and Taxation Department with regard to payment to Professional Tax.
5. An affidavit on stamp paper of Rs: 50/- duly authenticated by Notary Public to the effect that the firm or contractors has never been black listed from any Government, Semi Government Department or Private Department, not bank loan, Government dues defaulter and not indulge in any criminal activities.
6. Photostat attested copy of valid computerized National Identity Card of the Contractor.
