 - I. First envelop marked: "EARNEST MONY FOR THE TENDER NO.UCG/ELECT-109/13" should contain:

- The Bid Bond to be valid for 120 days from the bid closing date.
- > A copy of the first page of the received Tender Documents.
- 2. Second envelop marked: "TECHNICAL OFFER" should contain:
 - > The technical documentation and technical specification with references, statements, literature, drawings as appropriate. An unpriced financial offer shall be made part of the technical offer.
- 3. Third evelop marked: "FINANICAL OFFER" should contain:
 - ➤ A financial offer
 - A price sheet as per Appendix "A" of the form of Contract. Additional price information, if any, to be submitted on separate sheet. Itemized prices shall be quoted by bidder.

NOTE:

- No price to be shown in first or second envelop.
- Third envelop should contain Prices Only, with no reservations.
- Failing to submit three envelopes or omitting any of the requested information will lead automatically to the rejection of the Bid.
- Envelopes shall be opened in the same sequences as requested.
- The evaluation of any company shall not be continued in case they fail to meet the criteria of the envelop requirements.
- d. The tenders will be received backup to 28-11-2013 at 11:00 and:
 - A. "Technical Bids" will be opened on the same day at 12:00hrs in the presence of Purchase Committee and the bidders or their authorized representatives who wish to be present.
 - B. "Financial Bids" will be opened on 03.12.2013 in the presence of Purchase Committee and the bidders or their authorized representatives who wish to be present.

- e. Bid Security amounting to 2% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.
- f. The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
- g. Amount of the tender is below Rs.01 Million.
- h. Conditional tender and tender without bid security shall not be considered.
- i. Delivery time will be 10 days starting after the issuance of supply order.
- j. GST/Income Tax Exemption Certificates, as the case may be, must be accompanied with the tender.
- k. The procuring agency may amend quantities / reject all or any bid at any time prior to the acceptance of a bid or proposal, subject to the relevant provision of SPPRA Rules 2010.
