IMPORTANT

Tenders are required to abide by all the terms and conditions appearing below from Serial No.01 to 22 along with submission of all the relevant required documents. In Case of any tenders deviating from or fail to supply documents, such tender will not be considered for acceptance and will be rejected.

TERMS AND CONDITION

- In this tender method of procurement as per sindh public procurement Rules 2010 will be ONE STAGE SINGLE ENVEOPE PROCEDURE.
- The Town Health Officer Bin Qasim Town, Sindh Government Karachi does not bind itself to accept
 the lowest tender; each produce shall be assessed for approval on the criteria of Economy plus quality.
 This condition applies for essential as well as General Medicines/Drugs.
- No firm shall be allowed to participate unless registered with the Income Tax Department.
- Only those suppliers who are registered with the Sales Tax Department are eligible to quote for items on which Sales Tax is levied. Photocopies of the Sales Tax Registration Certificate Should be attached with the tender.
- Rates once approved will be operative for the whole financial year ending on 30:06: 2014.
- The rates shall be quoted on the attached < LIST OF GOODS & QUNTITIES >.
- The rates shall be quoted by Pen, BallPoint or may be typed, No overwriting in rate will be accepted. All
 correction must be initialed and each page is to be signed and stamped at the bottom.
- 8. In case of failure of any Tenders to execute the purchase order in accordance with the terms And conditions laid down in the tender the amount of the bid security shall be forfeited and stores will be purchased at the risk and cost of the Tenders (Approved supplier).
- If none of the items quoted by a bidder is approved, the bid of the firms will be returned on the request of the firms as per rules.
- 10. The quantities in the tender (List of Goods and Quantities) are approximate, variable for the Purchase according to the requirement during the current financial year 2013-2014. The contract shall be for the whole financial year. The contractor will be responsible to Supply the Goods within the time and to the quantity mentioned in each supply order.

- 11. In case of the offer is with drawn, amended, or revised during the validity period of the offer. The earnest money is liable to be forfeited in lieu thereof.
- 12. The procuring agency reserves the rights to claim compensation for the loss caused due to delay in the delivery of the stores.
- 13. Any conditional, ambiguous or incomplete offer in any respect shall be ignored and no supplementary or revised offer after the opening of the tender shall be entertained.
- 14. The Tender is also required to submit a Bank draft / Pay order equivalent to 2% of the quoted Amount (Refundable) as bid Security / earnest money in the name of Town Health Officer Bin Qasim Town, Sindh Government Karachi.
- 15. The procuring agency reserves the rights to accept or reject any one or all offer / Tender without showing any reason thereof.
- 16. The decision of the Procurement Committee will be final.
- 17. When the bid has been approved, the bidder will have to execute an agreement and a stamp paper of appropriate value for the due performance of the contract.
- 18. All the suppliers will have to deliver at the premises of main store, on the supplier's risk and Cost. Any breakage, shrinkage or storage of stock during the delivery will be recovered from the supplier.
- 19. The supplies should have 80% of shelf life.
- 20. The bidders are advised to read the Sindh PPRA Act 2009 and SPP Rules 2010 carefully before submission of bids.
- Conditional tenders will not be accepted.
- 22. In case of violation of any clause/terms and condition of the tender, the tender will be ignored.
