FOR SUPPORT, MAINTENANCE & CONNECTIVITY FOR THE VIDEO CONFERENCING SERVICES (TRUNKEY BASIS)

Information, Science & Technology Department has successfully deployed a project titled Video Conferencing System in Sindh. The main objective of the project was to establish face to face interaction between district heads and their high-ups at headquarters Karachi.

Information, Science & Technology Department, Government of Sindh, invites Technical and Financial Proposals (Separately Sealed) for the "Support, Maintenance & Connectivity for the Video Conferencing Services" under single stage-two envelopes bidding process, under SPPRA 2010 from all qualified companies to implement this component on TURNKEY basis.

Scope of Services / Term of Reference:

- 1. Support and maintenance of existing Video Conferencing equipment at 29 sites on turnkey basis.
- 2. Bandwidth required up to 30th June 2014 for 29 sites.
- 3. Support and maintenance of network devices installed at 29 sites.
- 4. Support and maintenance of bandwidth at 29 sites.
- 5. Resident Engineer for 29 sites.
- 6. Event Management.
- On-Site visit to resolve critical issues.
- Software upgrades.

Sealed Tenders comprising Technical and Financial proposals in separate sealed envelopes with clear marking of "Technical Proposal" and "Financial Proposal" in duplicate along with 2.5% earnest money of the quoted amount of the total bid in the form of Pay Order / Demand Draft should be dropped / submitted at the office of Section Officer (General), Information, Science & Technology Department, Government of Sindh, 1st Floor, Sindh Secretariat Building No.6, Shahrah-e-Kamal Ataturk, Karachi, on or before 19th December 2013 at 2:00 pm. Further information / clarifications may also be obtained from the same office.

Technical Proposal of the participation bidders will be opened on the same day at 3:00 pm in presence of bidders or their authorized representatives who may like to be present in the Committee Room of Information, Science & Technology Department, Government of Sindh, 1st Floor, Sindh Secretariat Building No.6, Shahrah-e-Kamal Ataturk, Karachi, and intending bidders or their authorized representatives. In case the bids could not the opened on the above stated date, the same would be opened on next working day at the same time.
- Pre-bid meeting would be held on 10th December 2013 at 2:00 pm at the Committee Room of Information, Science & Technology Department, Government of Sindh in the presence of the Secretary / Special Secretary, Information, Science & Technology Department.
- 5. Financial Bids of only technically qualified bidders shall be opened, subsequently in accordance with rules and procedure

Only bids offered on the prescribed tender from issued by the office of Section Officer (General), Information, Science & Technology Department, Government of Sindh, 1st Floor, Sindh Secretariat Building No.6, Shahrah-e-Kamal Ataturk, Karachi, shall be accepted. However, additional sheets may be attached, if necessitated.
