ii.	Bio data of Engineers and technical staff working with the firm.	
iii.	Documentary evidence of works executed/works in progress and certificate of satisfactory completion of works by the employees.	
iv.	List of works in progress indicating cost of each work and copy of letter of award of work / work orders.	
v.	List of machinery and equipment available with documentary evidence of its ownership certificates of Bank showing credit worthiness alongwith Bank statement.	
4.	Registration with Income Tax department (NTN Certificates) and copy of N.I.C.	
5.	Under taking on affidavit that firm is not involved in any litigation or abandoned any work in the department.


