EXPRESSION OF INTEREST FOR PRE-QUALIFICATION Bus Rapid Transit System “YELLOW LINE”



Introduction

In pursuance of the special directives by the Honorable Chief Minister, Sindh, Pakistan to alleviate the traffic problems of Karachi city, the Transport and Mass Transit Department, Government of Sindh (GoS) in collaboration with Public Private Partnership Unit, Finance Department, GoS invites Expression of Interest (“EOI”) for Pre-qualification of reputable and experienced firms (local, regional and international) /consortia/ or Joint Ventures for development, operation and maintenance of Infrastructure, Bus Operations and Revenue Collection & ITS System for Bus Rapid Transit System (“BRTS”) – Yellow Line (“Yellow Line”) under Public Private Partnership (“PPP”) mode.

The Project

BRTS “Yellow Line” is a 26 Km route (approx) starting from Dawood Chowrangī to Numaish Chowrangī & Regal Chowk via 8000 Road, Korangi Road and FTC.

Mass Transit Cell (MTCCell), Transport and Mass Transit Department wants to prequalify potential firms/consortia for the implementation of the Project. The Pre-Qualified bidders will be issued detailed Request For Proposal (“RFP”).

Project Structure

The detailed scope of work to implement the project shall be provided at the RFP stage. The project is being procured as three separate contracts for the major components of the project namely:

- Infrastructure Development
- Bus Operations
- Revenue Collection & ITS System

The captioned components of the Project are being bided out independently. However, Prospective Bidders are welcome to participate in more than one category of the above three components.
