Terms of reference

The Government of Sindh in Transport & Mass Transit Department is intending to hire the services of legal expert / professional for a period of one year as per following T.O.R:

- i. Defend and appear in all cases of Transport & Mass Transit department, Government of Sindh pending or coming before district courts, Sindh High Court and Supreme Court of Pakistan.
- ii. Responsible to draft and file case (including appeal / review / reversion) on the instruction and behalf of T&MTD as and when required.
- iii. Responsible to defend all cases on behalf of Transport & Mass Transit Department, Government of Sindh and draft and file affidavits, Counter Affidavits, written statements, Objections, counter Objections, para wise comments Intra court application and Miscellaneous any other suitable work as may be assigned from time to time after approval of the Secretary Transport & Mass Transit Department, Government of Sindh through additional Secretary (Transport).
- iv. Advise the Transport & Mass Transit Department, Government of Sindh on legal matter as and when required.
- v. Not appear, act or advise against the Transport & Mass Transit Department, Government of Sindh interest in any case / matter whether pending in court or not.
- vi. Any information / documents provided to the consultant by this department or coming in knowledge by virtue of being engaged by this department shall not be divulged / disclosed by the legal consultant to any unconcerned person.
- vii. He should bound to submit progress report of cases on fortnightly basis.
- viii. The consultant shall sit in his existing office, however, office will be provided by this department as and when needed.
- ix. He should bound to inform to Transport & Mass Transit Department of any court order passed by the court of law with its status.
- x. The consultant will be paid monthly fee of Rs. 50,000/= (Rupees fifty thousand only) per month plus Rs. 50,000/= (Rupees fifty thousand only) as miscellaneous charges against court expenses and stationery.
