- a. Blank tender forms can be collected from the office of Procurement Officer, UCG Project Thar, upto **30 January 2014 at 12:00 Noon**, during office hours after depositing the tender fee amounting to Rs.500/- (Non Refundable) in the shape of pay order in favor of Accounts Officer, UCG Thar Project, Islamkot.
- b. The tender documents will be received back upto **31 January 2014 at 11:00** and will be opened on the **same day at 12:00hrs** in the presence of Procurement Committee and the bidders or their authorized representatives who wish to be present.
- c. Bid Security amounting to 2% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.
- d. The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
- e. Bids validity should be for six months on following terms and conditions;
 - a. Rates should be quoted as per Government Control rates (Govt. control rate list should be attached).
 - b. Suppliers profit should be mentioned separately with all other taxes.
 - c. Rates should be quoted on F.O.R basis, if not then it should be mentioned clearly.
 - d. Any decrease / increase in Government Control Rates, quotation can be revised and will be adjusted accordingly.
 - e. Necessary certificates, i.e. GST / NTN/BOC labels or authorized dealership certificates should be attached with bid.
 - f.

- g. Successful party has to sign the agreement with the UCG for the supply of 06 months.
 - h. Payment will be made on monthly basis after receipt of original bill.
 - i. In case of termination of contract three months notice will be given by either party.
- f. Amount of the tender is below Rs.01 Million.
- g. Conditional tender and tender without bid security shall not be considered.
- h. Supply order will be issued periodically as per requirement of UCG project under the limit of total required quantity per year.
- i. Delivery time will be effective immediately after the issuance of supply order.
- j. The procuring agency may reject all or any bid at any time prior to the acceptance of a bid or proposal, subject to the relevant provision of SPP Rules 2010.
- k. Tender envelope should bear the tender No.UGC/Tender/Mech-145/14 and **Tender for supply of Welding Gases & Cylinders.**
