



PREQUALIFICATION OF ADDITIONAL CONTRACTORS/FIRMS

Water Supply, Wastewater and Solid Waste Management for Jacobabad City

Introduction

.

US Government through USAID/Pakistan is assisting Government of Sindh in implementing a 4 year Municipal Services Delivery Program (MSDP). This Program has been prepared to improve the municipal services infrastructure of selected towns/secondary cities of the Province as well as to meet the basic needs of the affected areas of the 2010 floods. This program will primarily emphasize on providing safe drinking water, better sanitation facilities and solid waste management.

2. Scope of Work

> Type-A (Water Supply and Allied Works)

The related works have been divided into different packages e.g. water supply works for transmission and filtration works, water distribution and house connections, in different zones, repair and maintenance of pumping stations, rehabilitation/reinstatement of roads, installation of electro-mechanical equipment with/without installation.

Remaining Water Supply contract packages to be tendered are as under:

- Contract Package WS-04 (Water Distribution Network Zone 1 & 2)
- Contract Package WS-06 (Water Distribution Network Zone 5 & 6)
- Contract Package WS-15 (Water Filtration Plant)

The estimated cost of either of packages (4, 6 and 15) ranges between Pk. Rs. 160-270 Million

> Type-B (Wastewater System and Allied Works)

The improvement/rehabilitation of proposed wastewater network has been divided into **four packages**. Each package would include all or some of the following works:

(Open tertiary drains, Covered primary and secondary drains, Cleaning/de-silting of existing drains, Connection of new RCC drains with the existing drains, Rehabilitation/reinstatement of roads, Construction/rehabilitation of oxidation ponds, Construction/renovation of pump houses, rising main works).

The estimated cost of either of four packages ranges between Pk. Rs. 270-350 Million

3. Completion Time for Each Package: 12 Months

4. Prequalification Eligibility:

Having valid license from Pakistan Engineering Council in Category C2 or above in discipline Civil with specialization in CE-09 & CE-10 and registered with relevant tax authorities. Firms registered in Category C3 or above in same discipline are also eligible for some packages of A Type works (for works costing less than Rs.250 Million).

5. Prequalification:

Interested national construction firms/JVs for both Types of works mentioned above may obtain the prequalification documents:

- a. Either personally from the address given below on payment of a non-refundable fee of Rs. 2,000/-only;
- b. Or may apply to get by post/courier on additional charges of Rs. 200/-; however, in any case, PMU will not be responsible for any delay in delivery/loss/tempering of the documents sent through post/courier.
- c. Or downloaded from website of SPPRA and Bank draft /payee's order of Rs. 2,000/-be attached @ time of submission of documents. www.pprasindh@gov.pk
- **6.** The following must be mentioned on the request letter:

"Application for Prequalification Documents for Type-A (Water Supply and allied works)/Type B Wastewater System and allied works."

However:

- Those contractors/firms already prequalified for these Types of works need not apply again;
- ii. Pre-qualification Documents for each Type of work are to be purchased separately.

7. Last Date and Time for Issue of Documents:

The prequalification documents will be issued to the interested firms from the date the advertisement is published in newspapers upto 1600 hours on Monday the 10th February, 2014 during office hours on payment of non-refundable fee stated above.

8. Last Date and Time for Submission of Prequalification Documents:

Documents duly filled-in and attached with relevant certificates/documents must be submitted at the address mentioned below on or **before 1400 hours on Wednesday the 19th February 2014.** Only the prequalified contractors/firms will be invited to bid. Interested firms may submit their inquiries/applications/documents to the address mentioned below.

- **9.** The Procuring Agency reserves the right to reject conditional or any proposal as per relevant provisions of SPPRA Rules 2010.
- 10. The applicants will be informed of the evaluation results of their prequalification applications within a reasonable time. Only short listed contractors/firms shall be allowed to participate in the bidding.
