Sealed tenders are invited in accordance with the Sindh Public Procurement Rules, 2012 for contractors/contracting firms for following works of the Police Department, Government of Sindh, Karachi.

TERMS & CONDITIONS:

- Contractors/Contracting Firms should be registered with Pakistan Engineering Council, Labour & Tax Department (NTN and STN registration certificates will be required).
- Contractors/Contracting Firms are advised to quote rates on Unit/Job/Per Sq.Ft./Rft. basis.
- Payments shall be made for the works on basis of job, unit basis as the rate mentioned in the scope of each item/work, on the basis measurement & verification in accordance with the specifications.
- The Contractors/Contracting Firms will be required to show affidavit of assets, solvency, respect of personnel/machinery, financial position etc.
- Contractors/Contracting Firms black listed by Government Departments are not allowed to participate in the tender/bid (participating contractors/contracting firms will have to submit affidavit to the effect that they are not black listed), for any Government Department.
- Contractors will be required to provide copy of CNIC and Contracting Firms will be required to provide Certificate of Registration.
- Only bids offered on the prescribed Tender Form issued by this department shall be accepted. However, additional sheets may be attached, if required.
- Conditional tender / application will not be entertained.
- Validity of bid/offer shall be at least 90 days for the date of opening of tender, i.e. refer to the 30th June, 2014.
- The competent authority reserves the right to reject all or any tender, to any extent, in accordance with the relevant provisions of the Sindh Public Procurement Rules, 2012.

- Complete set of bidding documents containing the scope of work and relevant details along with specification can be obtained by the interested Contractors/Contracting firms from the office of AD (Development), Room No.027, Block 'D', Central Police Office, Sector '11', Convent Road, at 10:00 am during working hours up to (18) days of the date of publication of the tender document (i.e. fee (non refundable).
- Tenders/Bids (duly sealed along-with call deposit) shall be accepted in the office of AD (Development) office of AD/Development at the address given above) on or before 08th Feb, 2014 up to 03:00 pm. The tenders/bids will be opened by Departmental Committee on 3:00 pm in presence of all authorized representatives (to may like to be present) of Contractors/Contracting firms participating in the tender/bid.
- Any other information relating to this tender/bid or detail of work or any further clarification can be obtained from the AD/Development at given address during office hours before opening of bids.
- The Contractors/Contracting Firms are advised in their own address to any circumstances relating to work and quality/quantities. They may also visit the site to assess the amount of additional/incidental work (availability of electricity, water or any other item which may be required before or during execution of the work of this tender for the reason of the above mentioned) issued by Police Department for such eventualities not any extension in time will be considered, and pretext.
