 - Documentary evidence of work executed/works in progress and certificate of satisfactory completion of works by the employers.
 - List of works in progress indicating cost of each work and copy of letter of award of work.
 - List of Machinery and equipment available with documentary evidence of its ownership Certificate of Bank showing credit worthiness along with Bank Statement.
- Registration with Income Tax Department (NTN) Certificate and copy of CNIC.
- Undertaking on affidavit that firm is not involved in any litigation or abandoned any work in the department.
- The bidders should submit earnest money as shown against each work in shape of call deposit prepared from the scheduled bank in favor of the undersigned.
- Affidavit to the effect that the firm/contractor have not been black listed previously by any executing agency.
- Affidavit with effect that all document/particulars/Information furnished are true correct.
- In case of firm, list of partnership deed, giving full particulars of Directors/proprietors or other connected along with power of attorney. In case of being sole proprietors such undertaking an affidavit be furnished.
