1. Tender documents will be issued to the firms on submission of application in their original letterhead along with the payment of cost of tender documents in cash mentioned against the scheme (Non-refundable) during working hours at the office of undersigned from the date of publication up to 17-03-2014, 1:00 P.M. No tenders will be sold on the tender opening date.
2. In case of any reason, the tenders are not responded on the above dates, the next of submission and opening will be 24-3-2014 and the tender documents will also be available up-to 21-3-2014.

3. The tenders in sealed cover superscripted with the name of work should be dropped in the tender box kept in the office of undersigned by **2:00 P.M** on 18-3-2014 and opened by the Tender Opening Committee **on the same day at 3:00 p.m.** in the presence of those representatives who wish to be present. Bid Security / Earnest Money @ 2% of the total value of offered bid in shape of call deposit / pay order of any scheduled bank in the name of Executive Engineer, Education Works Division-II Karachi must be attached with bid in sealed cover otherwise the tenders will be rejected. The bidders must produce original PEC Registration for the year 2013, original CNIC, certificate of proprietor / partnership deed at the time of opening of tenders.
4. The contractor must mention their complete and correct present postal address in tender documents & quote the rates both in words & in figures. Incomplete / Conditional tenders will not be accepted. In addition, the bidders must furnish the documentary evidence against each eligibility criteria as mentioned above. Otherwise, their tender will be summarily rejected without consideration of their bid amount.
5. The successful bidder will furnish a performance guarantee at the time of agreement in shape of Pay Order / Bank Guarantee equal to 5% of sanctioned cost. This guarantee will be released after completion of work.
6. An amount equal to 5% from each bill will be deducted as Retention Money which will be released after successful expiry of maintenance period.
7. In case, the date of opening declared as a public holiday by the Government, or non working day due to any reason the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
8. The procuring agency may reject all or any bids or proposals at any time prior to the acceptance of a bid or proposal subject to the relevant provision of SPPRA Rules 2010.
9. Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who report canvassing will liable for rejection.
10. Tenders will not be received after the schedule time.
