

Note: G. I. pipes must be of medium grade equivalent to ILL quality.

- Blank tender forms can be collected from the office of Procurement Officer, UCG Project Thar, upto **17-03-2014**, during office hours after depositing the tender fee amounting to **Rs.500 (Non Refundable)** in the shape of pay order in favor of , UCG Project Thar, National Bank of Pakistan, Islamkot.
- The tenders will be received backup to **18-03-2014** at **1100 hrs** and will be opened on the same day at **1200 hrs** in the presence of Purchase Committee and the bidders or their authorized representatives who wish to be present.
- Bid Security amounting to 2% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.

- d. The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
- e. Amount of the tender is below Rs.1 Million.
- f. Conditional tender and tender without bid security shall not be considered.
- g. Delivery time will be 10 days starting after the issuance of supply order.
- h. GST/Income Tax Exemption Certificates, as the case may be, must be accompanied with the tender.
- i. The procuring agency may amend quantities / reject all or any bid at any time prior to the acceptance of a bid or proposal, subject to the relevant provision of SPPRA Rules 2010.
