

NOTICE FOR PRE-QUALIFICATION OF CONTRACTORS

 - 1.1 **Scope.**
 - 1.1.1 **Construction of Sindh Secretariat Complex No.7.**

This consists of 6 Nos buildings Blocks – one block will be of G+ 15 & other 5 blocks will be of G+5 having total covered area of 930000 Sft with basement parking, ancillary works, landscaping & external development works.
 - 1.1.2 **Construction of Sindh Secretariat Complex No.8.**

This consists of 4 Nos buildings Blocks – one block will be of G+15 & other 5 block will be of G+5 having total covered area of 900000 Sft with basement parking, ancillary works, landscaping & external development works.
 - 1.2 **Estimated cost.**
 - 1.2.1 Secretariat No.7 PK Rs.3000.00 (Million) equivalent US \$ 28.300 (Million).
 - 1.2.2 Secretariat No.8 PK Rs.2900.00 (Million) equivalent US \$ 27.350 (Million).
