- 2. The rates offered would be valid for 60 days from the date of opening of the tender.
- 3. Sealed tenders along with 2 ½ % bid money in shape of Pay Order/ Demand Draft from any scheduled Bank in favour of Director, Directorate of Human Rights Sindh should be dropped in the box placed for the purpose at the address mentioned below on 27-03-2014 up to 3:00 pm which will be opened on the same day at 04:00 pm by Procurement Committee in presence of bidders or their authorized representatives who are to be present. In case the opening date is declared as a public holiday by the Government then



- the next official working day shall be deemed as the date for submission and opening of tenders at the same time.
- 4. Bid security shall be released to the unsuccessful bidder's once the contract sign with the successful bidders or the validity period expires.
- 5. Conditional tenders will not be accepted.
