Tender proforma alongwith copy of terms and conditions can be obtained from the date of publication in daily Newspapers, on the prescribed payment in the form of Bank Challan (Non Refundable) in favour of Karachi Metropolitan Corporation, as mentioned in the above schedule from office of (i) The Accounts Officer of the Office of Senior Director, Medical & Health Services, KMC, 2<sup>nd</sup> floor, Civic Centre, Gulshan-e-Iqbal, Karachi, (ii) Financial Advisor, KMC, 6<sup>th</sup> floor, Civic Centre, Gulshan-e-Iqbal, Karachi, and (iii) Director, Medical Services, Medical & Health Services, KMC, near Islamia College Karachi, on any working day.

**The bidding shall be on "Single stage – Two envelope procedure"**

1. 1<sup>st</sup> Envelope should contain Technical proposal only (on the basis of group in a single Technical Bid) and be clearly marked "Technical Proposal".
2. 2<sup>nd</sup> Envelope should contain "Financial Proposal" (Item wise rate of the quoted items of the group alongwith earnest money @ 2% of the total amount of the quoted rates in shape of Pay Order / Demand Draft in favour of Karachi Metropolitan Corporation, refundable to unsuccessful bidders). The envelope be clearly marked as "Financial Proposal".

### CLARIFICATION

- (a) The rate of each item should be quoted separately and alongwith earnest money of the total items of group be sealed in a separate envelope and labeled as "FINANCIAL PROPOSAL". Name of Group and name of the firms / company be written in bold letters on the envelope otherwise this will not be entertained.
  - (b) Both envelope (Technical and Financial) already sealed on individual basis should be sealed in a third envelop. The name of the bidder / firm be clearly marked on all envelopes.
  - (c) Tender should be dropped in the tender box kept in the office of the Director Medical Services, KMC @ Jigar Muradabadi Road Opp. Islamia College Gurumandir Karachi, on the above mentioned date and time.
3. The **Technical Proposals** of bids shall be opened in the office of the Director Medical Services, KMC @ Jigar Muradabadi Road Opp. Islamia College Gurumandir, Karachi, **on above said date and time** in the presence of bidders or their nominated representatives who wish to attend.
  4. The samples (if required) of the quoted items should be submitted with the tender documents.
  5. The **Financial Proposals** of the technical accepted bids recommended by the technical committee will be opened in the presence of bidders and their representative. Financial proposal of the technically un-qualified bids shall be returned to the bidders un-opened.
  6. The Government / KMC notified black listed firms / suppliers / contractors shall not be entertained.
  7. In case the tender is not opened on schedule dates due to announcement of Public Holiday, or any un-favourable circumstances, the same shall be opened on next working day same time.
  8. The procuring agency may reject all or any bid subject to the relevant provision of Sindh Public Procurement Rules.
