

INVITATION FOR BIDS

- 1- The Enhanced HIV/AIDS Control Program is a leading public health program in Pakistan. The Government of Sindh is implementing Program in Sindh through Department of Health. The Enhanced HIV/AIDS Control Program is providing leadership role in implementation of Program throughout Province.
- 2- The Enhanced HIV/AIDS Control Program Sindh has extensive network of Preventive and /curative Services like 12 Service Delivery Packages (for Injecting Drug Users, Male Sex Workers, Female Sex Workers, Truckers, Jail Inmates and Street Children MARA), 05 HIV/AIDS Treatment & Care Center, 02 PPTCT (Prevention of Parent to child Transmission) Sites, 21 VCCT (Voluntarily Counseling & Confidential testing) Centers and 46 STIs (sexually transmitted Infections) Clinics.
- 3- The above mentioned services are being provided free of cost to vulnerable groups and general population throughout sindh at teaching & district headquarter hospitals level.
- 4- The Enhanced HIV/AIDS Control Program, Health Department, Government of Sindh invites sealed bids from eligible bidders for the supply of medicines necessary for operation of its Preventive and Curative Services.

- 5- The interested bidders may obtain further information and Selection Criteria (Data Sheet) from - **31ST March 2014** till **17th April 2014** on submission of written application from the address given below from **10:30hrs to 16.00hrs** and upon payment of a nonrefundable fee of Pak Rupees 1000/= (One Thousand Only) in cash/bank draft/pay order in favor of the Enhanced HIV/AIDS Control Program.
- 6- The bidders are required to submit 05 copies of Financial Proposals as per details/specification given in data sheet, following single stage one envelope procedure.
- 7- The bidders are requested to give their best and final prices as no negotiations are allowed.
- 8- The bidders will be selected in accordance with the procedures set out in Sindh Public Procurement Rules 2010.
- 9- The Proposals should reach the address given below on **21st April 2014 by 01:00 pm** and must be accompanied by 2% Bid security in shape of Pay Order or Bank Draft in the name of Enhanced HIV/AIDS Control Program Sindh.
- 10- Bids will be opened in the presence of bidders or their authorized representatives **on 21st April 2014 at 02:00 pm** in the office of the Provincial Program Manager, Enhanced HIV/AIDS Control Program, Karachi.

- 11- As provided in the Bidding Documents, bidder(s) engaged in corrupt or fraudulent practices (including collusion/ polling) will be declared ineligible either indefinitely or for a stated period of time by the purchaser.
- 12- The purchaser reserves the right to accept or reject any/all bid(s) without assigning any reason to the bidder(s) as per provision of Sindh Public Procurement Rules 2010.
