3. If any tender remain un-responded, same will be extended upto **10-05-2014** and will be opened on same day at 12:00 Noon.



 - iii. Details of works executed during the last five year including copy of certificate for satisfactory completion of works by client.
 - iv. Documents proof and ownership of available Machinery and T&P.
 - v. List, scope and approximate cost of works in hand.
 - vi. Financial stability certificate issued by a schedule Bank.
 - vii. Affidavit in which the bidder undertakes that, it is not involved in any litigation.
 - viii. Affidavit in which it should be undertaken that, the information provided is true and correct.
 - ix. Affidavit that, the bidder has not been black listed by any Government/Semi Government/Autonomous body.
