1. The Program Management & Implementation Unit – Sindh Basic Education Program invites sealed tenders on item rate basis from interested eligible contractors / firms.

2. **Eligibility:** The suppliers must fulfill the following criteria:

- i. Registration with FBR, SRB and other relevant authorities.
- ii. At least 05 years' experience in providing equipment and related services.
- iii. Good repute.

3. **Qualification:**

- i. List of similar assignments
- ii. List of litigation (if any) their nature and status/ outcome.
- iii. No blacklisting by any procuring agency.
- iv. NTN certificate & copy of CNIC.

4. **Method of Procurement.** Single Stage Single Envelope

5. **Bidding / Tender Documents:**


- a. **Issuance:** Separate bidding documents of each Package will be issued from date of publication up-till 1700 hrs on 05-05-2014, at a cost of Rs. 500/- for each package as mandatory non-refundable tender fees for the processing of bids in the form of pay order / demand draft drawn in favor of "DDO, SBEP - PMIU".
- b. **Submission:** Sealed bids with the name of the Package written on the envelope accompanied with bid security sealed envelope must be submitted to the Program Director - SBEP, at or before 1300 hrs on 08-05-2014.
- c. **Bid Security:** The bids must be accompanied with a bid security of amount not less than 2.5% of the quoted bid amount in the form of pay order / demand draft drawn in favor of "DDO, SBEP - PMIU". The bid security shall remain valid for a period not less than 28 days beyond the bid validity period.
- d. **Opening:** Bids will be opened before the Procuring Committee on the same day i.e. 08-05-2014 at 1330 hrs in the presence of bidders' representative who chose to attend the same.

- e. **Place(s)** of issuance, submission, inquiries and opening will be at the Procuring Agency office: D-29, Block-2, Clifton Karachi, Tel No. 021-35296931, Fax No. 021-35296935.

6. **Funding Position:** Government of Sindh.

7. **Terms & Conditions.**

- a. Under following conditions bid will be rejected:-
- i. Conditional, part, electronic and telegraphic bids / tenders;
  - ii. Bids not accompanied by bid security of required amount and form;
  - iii. Bids received after specified date and time.
  - iv. Black listed firms.
- b. **Bid validity Period: - (90) days**
- c. The successful bidder shall be liable for payment of income tax, general sales tax, sales & service tax of Sindh Revenue
- d. Board, Stamp duty of Sindh Government and all other applicable taxes and fees as per provincial and federal laws in force on the total bid amount respectively.
