- 2. The last date of receipt of Tender is 08 05 2014 up to 1:00 PM and will be opened on same day at 2:00 PM in the presence of tender opening / evaluation committee and the bidders or their authorized representatives who wish to be present.
- 3. If due to unavoidable circumstances, the undersigned is out of head quarters, or in case the tenders are cancelled / rejected or un responded or minimum responsive time (15 days) to be completed after first publication of NIT in daily news paper, the next date for tender issue, receiving and opening will be as under:
 - Issue 08-05-2014, receiving on 09-05-2014 at 1.00 pm & opening at 2.00 pm on same day.
 - b. Issue 09-05-2014, receiving on 10-05-2014 at 1.00 pm & opening at 2.00 pm on same day.
- 4. Eligibility conditions for intending participants are as under:
- a. Full name of the firm along with organizational structure and permanent address with telephone number.
- b. Details of works executed by the contractors in the past ten years indicating scope of works, estimated cost and time taken for completion duly certified by the concerned officials.
- c. List and location of equipments, transport and machinery available with the contractor for this job.
- d. Affidavit that the contractor has neither been black listed by any agency nor involved in any subversive activities.
- e. Copy of fresh enlistment letter of Pakistan Engineering Council in C-4 or above category and authenticating the works of such amount carried out in building nation department.
- f. Bio-data of the technical staff permanently employed and available with the firm/contractor for this project.
- g. List of cases entered into arbitration/Litigation. If not involved then affidavit to the effect that the firm /Contractor was not involved in any litigation, no work was rescinded in the past.

h. List of work where penalty is involved, if any.

i. Any additional information the applicant may like to furnish in support of its paper.

5. If firm / partner involved in partnership deed, then complete details / instructions and power of attorney will be submitted in affidavit by the proprietor.

6. Conditional and Telegraphic tender will not be entertained.

7. The PEC, C-4 Category or above will apply for the package H&I work (combined).

8. The Procuring Agency through its Provincial Project Director National MNCH Program Sindh shall pre-qualify contractors based on technical evaluation report, depending upon magnitude & complexity of the projects and other conditions mentioned in criteria. The Technical qualified contractors financial bid will be opened in the presence of their representatives.

9. The firms interested may apply for tender Single stage two envelope bidding procedure and submit their proposals, Technical bid and Financial Bid on the prescribed form criteria to be obtained from the office of Provincial program Director National MNCH Program Sindh from 24th April, 2014 on Cash or pay order or

Demand Draft of Rs.2000/- (Non-Refundable).

10. The earnest money specified should be in the name of Provincial Program Director National MNCH Program Sindh" in the shape of call deposit i.e 2% of bid amount from any scheduled bank and must be attached with sealed bid documents, otherwise bid will not be entertained.

11. Time for completion of contract is 12 Months.

12. The Procuring Agency may reject all or any bids subject to the relevant provisions of SPPRA Rules 2010.
