Bid Security: - Bid Security as mentioned above in shape of pay order or bank guarantee or Insurance guarantee (on specified Performa) in favour of KMC shall be enclosed as follows: -

- Rs. 2,00,000/- shall be enclosed with Technical Offer Envelope as part of Bid Security. Otherwise the bid will not be evaluated.
- Rs 10,00,000/- shall be enclosed with Financial Offer Envelope. In case of non compliance, the part of Bid Security attached with the technical offer shall be forfeited
