No tender will be sold on the tender opening date. Moreover, interested bidders will have to appear in person for obtaining tender or nominate their representative in writing to get tender on their behalf.

The tender in sealed cover superscripted with the name of work, should be dropped in the tender box kept in the office of the Project Director, Surjani Town, CDGK by 2.00 pm on 28-01-2009. The tender submit by the bidders will be opened on the same day at 2.15 pm by the Chairman, Tender Opening Committee, Surjani Town, CDGK in presence of those bidders of their representatives who wish to be present. In case tenders could not be opened on the above date, the next date of tender opening will be 30-01-2009 and the tender documents will be available for same from 28-01-2009 to 29-01-2009 Similarly, if again the tender could not be opened then the opening date will be 02-02-2009 and tender documents will also be available from 29-1-2009 to 1-02-2009. In case opening date is declared public holiday, next day shall be deemed to be the date for submission and opening of tender at the same time.



Beside, 2% of the Offer Amount will also be attached with the tender in shape of pay order in favour of CDGK and will be dropped in the tender box on the date of tender opening. One firm can participate in one work only.

Canvassing in connection with the tendering is strictly prohibited and tender submitted by the contractor who resort canvassing will be liable for rejection.
