4/- The bidder must submit their bids along with 2.5% bid security of the total quoted cost in shape of pay order in favor of undersigned accompanied experience evidence, GST and Income Tax Registration Certificates in a sealed envelope, otherwise it will not be entertained.

5/- The bidder must be registered with Sales Tax and Income Tax. The Single stage one envelope procedure will be adopted only, the eligibility criteria of the bidders will be in accordance with the SPP rules 2010 under single stage one envelope procedure.

6/- The procurement agency may reject all or any of bid prior to acceptance in the light of SPP rules 2010. The conditional and telegraphic bids will not be entertained.

7/- The procurement will be carried out as per specification given in the bid document.
