TENDER NOTICE

1. Inspector General of Prisons Sindh invites sealed bids for supply of "Cooked Food" (Prison-wise) for the prisons in Sindh on daily basis (Break-fast, Midday & Evening Meals) in accordance with prescribed Diet menu and Scale at running rate contract basis for the year 2014-2015 according to single stage two envelopes procedure as per rule No.46 (2) of SPP Rule 2010 from the Authorized Persons / Contractors / Firms / Companies / General Order, bidders offering their bids, who must be registered with Sindh Revenue Board as well as Income Tax and Sales Tax department.
2. Bid documents containing details of prisoners, Terms & conditions, diet menu, scale and specification etc are mentioned in the bid document which can be had from the office of Inspector General of Prisons Sindh Camp at Central Prison Karachi by submitting application on their letter head on any working day during office hours from the first publication of Notice inviting tender in the newspapers as well as SPPRA website indicating therein name of Prison, on payment of tender fee of Rs.1000/- in cash non-refundable for each prison. The bid document is available at SPPRA website www.pprasindh.gov.pk and can be downloaded upto **28.05.2014** and same shall be received back upto **29.05.2014 at 12:30 pm** (complete in all respect) by hand only at office of the Inspector General of Prisons Sindh, Karachi and shall be opened on same day at **01:00 pm** in presence of bidders who intend to be present. In case, any public holiday falls due to any reason, on the opening day of bids, then it may be received and opened on the next working day at the given time and venue. The bidder who receives the bid document by downloading from website must attach tender fee in shape of pay order amounting to Rs.1000/- as mentioned above.
3. The bidder may submit one **Technical Proposal** for one prison or for requisite prisons for which he has purchased bid document, however financial proposal of each prison shall be separate.
4. Prison-wise **Financial Proposal** for supply of cooked food shall be separate mentioning therein rate of three times cooked food as elaborated in bid document of the respective prison and accompanied with bid security @ Rs.3% of the total cost of the bid, in shape

of Pay order / Demand Draft from any scheduled Bank of Pakistan, in favour of Inspector General of Prisons Sindh Karachi. The bids lacking the requisite bid security may be rejected. Besides, the bids offered by the Black listed firms shall not be accepted / entertained.

5. The opening of Bids and evaluation process shall be conducted by the committee notified under Rule No. 7 of SPPRA Rules 2010.
6. The rates offered must be inclusive of income tax or any other prescribed taxes.
7. The rate must be quoted in figures and words.
8. Conditional Bid / application shall not be entertained, in any case.
9. Any further information, if required may be obtained from the office of Inspector General of Prisons Sindh Camp at Central Prison Karachi on any working day during office hours or on phone No. 021-99231418 and fax No. 021-99231084.
10. The competent authority may cancel the bidding process at any time prior to the acceptance of a bid or proposal as per provision of rule 25(1) of SPP Rules 2010.
11. The competent authority reserves the right of seeking security clearance of successful bidders / employees on appropriate stage.
