- iii) Registration with Income Tax Department (NTN copy) and Sindh Revenue Board.(Sales Tax Registration) and copy CNIC.
- iv) Undertaking on stamp paper that firm is not involved in any litigation, Department rift, abandoned or un-necessary delay in completion of any work in the Government Department.
- v) The application Shall accompany of tender fee as shown against each for purchase of bidding documents.
- vi) The 2% Earnest Money shall be submitted in the shape of call deposit issued from scheduled bank t the time of submission of bidding documents in favor of undersigned.
- vii) Affidavit to the effect that firm has not been black listed previously by any executing agency.

- x) List of work and copy of letter of award of work/ work orders of equivalent cost or above.


