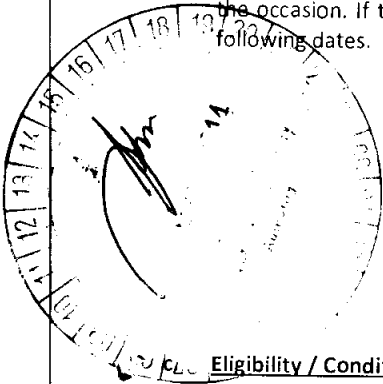


- xi) List of machinery and equipment available with documentary proof of its ownership and place of stores.
