The bidder will deposit a pay order/Demand Draft as Bid Security in favour of Sindh Seed Corporation equal to 2.5% of total cost.

The tender for service of Labour Contractor will be issued from the date of 1st publication of this Tender Notice to the date of opening i.e. 22-08-2014 upto 10:00 A.M. and will be received back upto 11:00 A.M. of the same date and will be opened at 12:00 Noon on the same day by the Procurement Committee in the office of Director Production, Processing & Marketing, SSC, Hussainabad, Hyderabad in presence of bidders/representative. In case of non-response, the Tenders will be again issued from 22-08-2014 to 08-09-2014 upto 10:00 A.M. and will be received back upto 11:00 A.M on 08-09-2014 and will be opened at 12:00

Noon on the same day. If the date fixed for opening bids is declared as Public Holiday, the bids will be issued upto 10:00 A.M on next working day and will be received back upto 11:00 A.M and will be opened at 12:00 Noon on the same day by the Procurement Committee in the Office of Director Production, Processing & Marketing, Sindh Seed Corporation, Hussainabad, Hyderabad. The bidder/contractor will be registered with Sindh Revenue Board.


The Tender for supply of bags will be issued from the date of 1st publication of this Tender Notice to the date of opening i.e. 22-08-2014 upto 1:00 P.M. and will be received back upto 2:00 P.M. of the same date and will be opened at 3:00 P.M. on the same day. In case of non-response, the Tenders will be again issued from 22-08-2014 to 08-09-2014 upto 1:00 P.M. and will be received back upto 2:00 P.M on 08-09-2014 and will be opened at 3:00 P.M. on the same day. If the date fixed for opening bids is declared as Public Holiday, the bids will be issued upto 1:00 P.M on next working day and will be received back upto 2:00 P.M and will be opened at 3:00 P.M. on the same day by the Procurement Committee in the Office of Director Production, Processing & Marketing, Sindh Seed Corporation, Hussainabad, Hyderabad.

The Sindh Sales Tax on services will be charged/deducted from the payment to be made to service provider and deposited in the Government of Sindh's head of account No. B-02384 at the applicable rates as prescribed under Sindh Sales Tax (Services) Laws. The Income Tax, other taxes etc. imposed by the Government from time to time will also be deducted from payment of bills, if applicable.

The Contractor should produce a certificate with bill of the concerned districts Excise & Taxation Officer that the Professional Tax has been paid.

The all rules mentioned in Sindh Public Procurement Rule-2010 will be applicable to the bidders/contractors.

The SSC reserves the right to reject all bids or proposals at any time prior to the acceptance of a bid OR proposal as per rule-25 of SPPR, 2010.
