

- a. Blank tender forms can be collected from the office of Procurement Officer, UCG Project Thar, up to **02 September 2014** during Office Hours, after depositing the tender fee amounting to Rs.500/- (Non Refundable) in the shape of pay order in favor of Accounts Officer, UCG Thar Project, Islamkot. Tender documents can also be obtained through email by submitting scanned copy of Bank Draft/ Pay Order however its original should accompany the tender otherwise bid will not be considered.
- b. The tender documents will be received back up to **03 September 2014** at 1100 Hrs. and will be opened on the **same day** at 1200hrs in the presence of Procurement Committee and the bidders or their authorized representatives who wish to be present.
- c. Bid Security amounting to 2% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.
- d. The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
- e. Amount of the tender is below Rs.01 Million.
- f. Conditional tender and tender without bid security shall not be considered.
- g. Delivery time will be 2-3 weeks starting after the issuance of supply order.

- h. GST/Income Tax Exemption Certificates, as the case may be, must be accompanied with the tender.
- i. The procuring agency may amend quantities / reject all or any bid at any time prior to the acceptance of a bid or proposal, subject to the relevant provision of SPPRA Rules 2010.
- j. Tender envelope should bear the tender No. UCG/Tender/Mech-209/2014 and Tender for Punching Machine, Hydraulic and Fittings.
