- d. The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
- e. Amount of the tender is below Rs.01 Million.
- f Conditional tender and tender without bid security shall not be considered. Delivery time will be 2-3 weeks starting after the issuance of supply order.
