The scale of diet to be supplied to the prisoners have been mentioned in the tender document (duly approved by the competent authority) OR as amended time to time by the competent authority.

NOTE: The special diet will also be provided by the contractor/supplier as per existing policy OR as per separate directions/orders on Eid and other occasions as well as during the month of Ramzan to under trial prisoners/ accused persons.

The contractors / interested persons shall submit the following documents along with the call deposit (earnest money 2%) as under:

1. Original purchased receipt.
2. Income tax and sales tax certificate duly attested by the Oath Commissioner Notary Public.
3. Detail of Experience certificates of running business of cooked food in Government, semi Government and Public sector.
4. Current Bank certificate in original to the effect that financial position of contractor / firm is sound (turn over of at least last 03 years).
5. NOC from Excise and Taxation Department with regard to payment to professional tax.
6. Bid security in shape of pay order // Demand Draft not below 2% and not exceeding 5% of the total cost of the bid.
7. An Affidavit on stamp paper of Rs.50/- duly authenticated by Notary Public to the effect that the firm OR contractors has never been black listed from any Government. Semi Government Department or private Department, not bank loan, Government dues defaulter and not indulge in any criminal activities.
8. Photostat attested copy of valid computerized National Identity Card of the contractor
