3. List of work executed during the last 10 years specially in Irrigation & Drainage Sector projects along with estimated cost and name of client.



6. Affidavit that the contractor has never been blacklisted by any agency.
7. Proof of financial capability including income Tax return of last 03 years.
8. Credit line certificate from the reputable bank.
9. Any additional information with supporting documents.

The Technical Proposals will be considered and evaluated in accordance with SPPRA Rules 2010. The interested contractors/ firms may obtain any further details regarding the project on any working day before the submission of the proposals.
