

- The tender documents will be received back up to **27 October, 2014 at 1500 Hrs.** and will be opened on the **same day at 1600 Hrs** in the presence of Procurement Committee and the bidders or their authorized representatives who wish to be present.
- Bid Security amounting to 1% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.
- The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
- Amount of the tender is below Rs.01 Million.
- Conditional tender and tender without bid security shall not be considered.
- Delivery time must be minimum starting after the issuance of supply order.
