

Pre Qualification Notice for Contractors/Firms

BULK GRAIN STORAGE FACILITY ON HIRING / RENTS BASIS.

The Regional Directorate of Food, Sukkur(RDFS) acting on behalf of the Food Department Government of Sindh, hereby invites pre-qualification applications from prospective bidders for bulk storage.

Storage facility is part of Government of Sindh strategy to improve the province's Agri Storage and handling infrastructure by introducing private sector investment aimed at reducing wastage, improving Sindh's Food security and provision of good quality wheat grain.

The Regional Food Directorate of Food, Sukkur requires private storage accommodation at Sukkur for storage of 50000 M.tons wheat each for about 15 years on hiring. The facility will be availed from 31st March, 2015 or later as will be decided by the competent authority.

Storage facility should ensure following parameters,

Structural Specification.

- Must have an easy access to main metal led road and should not be situated in low laying / flood hit water lodged/ non environment friendly area.
- Electricity and water connection alongwith a backup i.e. generator (200 KW) and a water storage tank.
- The Column, roof and flooring should be a concrete RCC structure and should with stand earthquake.
- Equipped with at least 2 weigh bridges, Stackers, Fork Lifters and Truck loader.
- Must have 40 ft wide road, in internal design for easy maneuverability of trolleys/ Trucks.

- f) Floor of the Godown must be at a raised level (4 feet) and plastered, with no pits
- g) Roof height of the Godown should be at least 12 meters.
- h) A Moisture Proof environment (12%) at 40-60 F
- i) A boundary wall of at least 8 feet (Height) for entire storage of wheat and the following Blocks.

Offices	2,000

- 4. Registered with SRB (Sindh Revenue Board)
- 5. Each side should be established as a Special purpose Vehicles (SPV) basis
