1. The Project Director intends to pre-qualify contractors for the work "Re-alignment / Construction of Bund from North side of Malir River Karachi. The components of the works shall consist of, but not limited to the following.

- Stone pitching.

2. Pre-qualification is open to contractors/ joint ventures who are registered with Pakistan Engineering Council in Category C-A and in disciplines CE 03, 04 and 10 for construction and operation of Civil works.

Interested firms/ Joint ventures/ Consortium/ Association may obtain the Pre-qualification documents available from 27-10-2014 on request from the Office of the Project Director, Re-alignment/ Construction of Bund from North Side of Malir River at Left Bank Barrage Colony, Hyderabad on payment of Rs. 5,0 % in cash, on any working day during the office hours till 12-11-2014 up to 2:00 P.M. These documents can also be downloaded from SPPRA website.

4. Applications for pre-qualification must be delivered in sealed envelope by hand or through courier services to the office of the undersigned not later than 12-11-2014 at 2:00 P.M. The applicants who downloaded the documents from SPPRA website should pay Rs. 5,000/- in cash at the time of submitting their documents. The documents received after 2:00 P.M. shall not be entertained. The same will be opened by the procurement committee in the presence of the intending firms or their representative at 3:00 P.M. on 12-11-2014.

5. Prequalification documents will be considered and evaluated in accordance with SPPRA Rules 2010 and Evaluation Criteria adopted by the Irrigation Department, Government of Sindh.
