- Contractor having NTN and copy must be available with tender in case of supply item the GST registration must be available with tender.
- 2. The pay Order of Bid Security as mentioned in NIT and must be available with the tender.
- 3. (3) Years Experience certificate of similar nature of job must be available with the tender.
- 4. Turnover Statement last 3 years.
- Similar nature of Bidding Documents form upto 2.5 Million of SPPRA with filling Bidding Data & Contractor Data must be available with BOQ other wise the tender cannot be accepted.
- 6. Rate must be quoted in figure & words by contractor.
- 7. Bid shall be properly signed by contractor with stamped, address and contract No.#.
- 8. If the estimate are based on Sch: 2012 and premium can be allowed within allowab e limit.
