- 01. Tender documents can also be obtained through email by submitting scanned copy of Bank Draft/ Pay Order however its original should accompany the tender otherwise bid will not be considered. Bids received through email can be rejected.
- 02. Submission of Tender Documents: The tenders will be received backup to 03-12-2014 at 1500Hrs and will be opened on the same day at 1600 Hrs at UCG Thar Project Site Bhambneo Bheel, Islamkot Mithi District Tharparkar in the presence of Procurement Committee and the bidders or their authorized representatives who may be present.
- 03. Eligibility: Valid Registration with tax authorities & Valid Dealership/ Stockist Certificates (Evidence of experience of dealership/ stockist in last three years, original Brochures and sample of the product must be submitted along with the bid).
- 04. Method of Procurement: Single Stage Single Envelope.

## 05. Terms & Conditions.

- a) Responsive Bidder is required to submit following documents with bid:
- Valid Registration with tax authorities & Valid Manufacturing/ Dealership/ Stockist (i) Certificates; (ii)
- List of similar assignments with cost (mention number of projects with their cost) undertaken over the last couple of years; (iii)
- Affidavit that firm has never been black listed;
- Financial Statement (summary) and income tax returns; (iv)(V)
- Original brochure and sample of the product i.e. peristaltic pump & Cartridge filter.
- b) Under following conditions bid will be rejected:-
- Conditional and telegraphic bids/tenders and not fulfilling terms and conditions (i) (ii)
- Bids not accompanied by bid security of required amount, Tender Form, and documents mentioned in para (a); Bids received after specified date and time. (iii)
- Firms black listed by any Department of Govt. of Sindh/ Govt. of Pakistan. (iv)
- c) Bid validity Period: (90) days.

- d) Bid Security amounting to 2% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.
- e) The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
- f) Amount of the tender is below Rs.1 Million.
- g) Delivery time will be 30 days starting after the date of receipt of supply order.
- h) GST/Income Tax Exemption Certificates, as the case may be, must be accompanied with the tender.
- i) Procuring Agency reserves the right to amend quantities/ reject all or any bid(s) subject to the relevant provisions of Sindh Public Procurement Rules 2010.
