- 1. Project Management Office, Sindh Barrages Rehabilitation Project (irrigation Department) has received funds from Sindh Province for the Project/Scheme cited above with Scope, Estimated Cost and duration of project are as under:-
 - (i) Scope: The outcome of feasibility/ survey study will describe in detail engineering proposal for the construction of the Barrage and its possible alternates in order conserve the flood water in River flood plan. The adopted proposal will also explore the option of barrage to supply a dual feeder canal system and storage adjacent to the barrage.
 - (ii) Estimate Cost: Rs. 40.00 millions
 - (iii) Scheme/Project Period: Nine (9) months.
- 2. Dead line of Submissions: Applications are invited from interested firms for short listing. The application along with following documents must reach on the address mentioned herein below on or before 3:00 pm on 12/12/2014). Request for Proposal (RFP based on QCBS) shall be issued to short listed consultants only.
- 3. Eligibility.

Valid Registration with Pakistan Engineering Council in Civil, Mechanical, Electrical, Hydrology and agriculture, *discipline*

- 4. Required Documents: It must include following details/documents:-
 - (A) Profile of Firm:
 - (i) Name, address, telephone, fax numbers and e-mail address of firm;
 - (ii) Ownership and Organizational Structure of the firm.
 - (iii) Year of Establishment.
 - (B) Experience and past performance.
 - (i) List of similar assignments with cost, under-taken in the past 5 years; (Minimum 1 number)
 - (ii) List of assignments of similar site/geographical condition (1 minimum number
 - Performance certificates of assignments /projects completed are to be attached.

(C) Key Personnel Qualification & Experience.

List of Permanent Engineering staff that showing Academic qualification and relevant experience. (Requirement must be B.E with minimum 5 years relevant experience)

(D) Financial.

- (i) Documentary evidence of financial position, e.g., a bank statement or audited accounts of the last 3 years.
- (ii) Annual turnover of the last 3) years.

 (Minimum annual turnover be Rs 100 million))
- (iii) Income tax return for the last three years.

(E) Any other information.

- (i) Details of disputes/litigation or arbitration with client(s)
- (ii) Affidavit that firm has never been blacklisted.

5. Evaluation Criteria:

- (i) Applications with required documents attached shall be evaluated on Pass or Fail/Yes or No basis (check list);
