

- i) Registration with Pakistan Engineering Council in the relevant category or above discipline keeping in view the bid costs for items shown at Sr.No:01.
- ii) For electrical work valid license issued from Inspectorate of Electrical License Sindh of the similar region with respect to works, shown above.
- iii) Documentary evidence of work of equivalent cost or above executed in last 3 years and Certificate of satisfactory completion showing date of start and completion from one employer.
- iv) List of work and copy of letter of award of work / work orders of equivalent cost or above.
- v) List of machinery and equipment available with documentary proof of its ownership.
- vi) Registration with Income Tax Department (NTN copy) and Sindh Revenue Board (Sales Tax Registration) and copy of CNIC.

- v i) Undertaking on stamp paper that firm is not involved in any litigation, Departmental rift, abandoned or unnecessary delay in completion of any work in the Government Departments.
- v ii) The 2% Earnest money shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding document in favor of undersigned.
- ix) Affidavit to the effect that firm has not been black listed previously by any executing agency.
- x) Affidavit to the effect that all documents / particulars / information furnished are true and correct.
