The Pre-qualification documents will be available from **23rd December 2014** in the office of the Executive Engineer Kotri Barrage Division, Jamshoro on the payment of **Rs. 2000/- only (Non refundable)** any working day during office hours till **7th January 2015**. The last date for the submission of the Pre-Qualification documents duly filled in is **8th January 2015**. Application for prequalification must be delivered in sealed envelopes by hand or through courier service to the **office of the Superintending Engineer, Baghar Circle Hyderabad** on or before **8th January 2015** Upto 2.00 PM. The Firms / Contractors who downloaded the documents from SPPRA website should pay Rs.2000/- in cash at the time of submitting their documents. The same will be opened by the Procurement committee in the presence of the intending firms or their representative at 3.00 p.m. on same date **8th January 2015**.

Prequalification documents will be considered and evaluated in accordance with SPPRA Rule 2010 and evaluation criteria adopted by the Irrigation Department, Government of Sindh.

The contractors / firms will be selected and engaged in accordance with the existing procurement SPPRA Rule 2010.

The interested Contractors / Firms may obtain further detailed regarding the project on any working day during office hours.


Joint Venture consisting of more than three (03) Firms shall not be eligible for the participation.

Any false information given by the contractor/firm shall result in disqualification.

Contractor should be registered with Sindh Revenue Board in terms of Rule-46(1)(iii) of SPP Rules, 2010 (Amended 2014)

The Contractor / Firms having sufficient experience in above type of Civil work will only be considered for prequalification.

Applicants will be informed the result of the evaluation in due course of time. Only the firms or contractors prequalified under this process will be invited to bid.
