01. Issuance of Tender Documents: Blank tender forms can be collected from the office of Procurement Officer UCG Project Thar, upto <u>09-01-2015</u>, during office hours after depositing the tender fee amounting to **Rs.500** (Non Refundable) in the shape of pay order in favor of UCG Project Thar, Islamkot. Tender documents can also be obtained through ernail by submitting scanned copy of Bank Draft/ Pay Order however its original should accompany the tender otherwise bid will not be considered. Bids received through email can be rejected.

- 02. Submission of Tender Documents: The tenders will be received backup to <u>10-01-2015</u> at 1500Hrs and will be opened on the same day at 1600 Hrs at UCG Thar Project Site Bhambneo Bheel, Islamkot Mithi District Tharparkar in the presence of Procurement Committee and the bidders or their authorized representatives who may be present.
- **03.** Eligibility: Valid Registration with tax authorities & Valid Dealership/ Stockist Certificates(*Evidence of experience of dealership/ stockist in last three years, original 3rochures and sample of the product must be submitted along with the bid where required*).
- 04. Method of Procurement: Single Stage Single Envelope.

05. Terms & Conditions.

a) Responsive Bidder is required to submit following documents with bid:

- (i) Valid Registration with tax authorities & Valid Manufacturing/ Dealership/ Stockist Certificates;
- b) List of similar assignments with cost (*mention number of projects with their cost*) under-taken over the last couple of years;
- c) Affidavit that firm has never been black listed;
- cl) Financial Statement (summary) and income tax returns;
- c) Original sample of the product i.e. Water Pumps.
- f) Under following conditions bid will be rejected:-
 - (1) Conditional and telegraphic bids/tenders;
 - (i) Bids not accompanied by bid security of required amount, Tender Form, and documents mentioned in para 5 (a);
 - (ii) Bids received after specified date and time.
 - (v) Firms black listed by any Department of Govt. of Sindh/ Govt. of Pakistan.

g) Bid validity Period: (90) days.

h) Bid Security amounting to 2% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.

i) The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.

j) Amount of the tender is below Rs.1 Million.

k) **Delivery time** will be 15 days starting after the date of receipt of supply order. Penalty will be imposed @ 2 % per month of cost of the tender on the late delivery.

1) GST/Income Tax Exemption Certificates, as the case may be, must be accompanied with the tender.
