The work includes Cement Concrete Lining of Jamrao Canal from mile 49 to 59 and West Jamrao Canal from RD 0 to 300 and Rehabilitation of Old Jamrao Canal from 0 to 32 miles Regulator alongwith construction of diversion canal at reaches in Sindh Province. The PQ documents will be available in the office of the Executive Engineer Jamrao Canal Mirpurkhas on the payment of Rs.3,000. Only (Non-refundable). The last date for the submission of PQ documents is within 15 days after publication of this advertisement.

The PQ Document submitted by the interested contractor / firm must include following information.

2. Bio-data of permanent technical staff along with managerial and organization setup.
3. List of works executed in last 10 years especially in lining of canals projects along with estimated cost and name of the client.
4. List of plants, equipments, transport and machinery available with the contractor / firm, specially lining machines and batching plants.
5. Copy of valid certificate of Pakistan Engineering Council in the relevant category CA (No limit).
6. Affidavit that the contractor / firm has never been blacklisted by any department / agency.
7. Proof of financial capability including income tax return of last three years
8. Credit line certificate from the reputable bank.
9. Any additional information with supporting documents.

The PQ documents will be considered and evaluated in accordance with SPPRA Rules 2010 (amended 2013). The interested contractors / firm may obtain any further information regarding the project on any working day. Before the last date of submission. The PQ documents in English language shall be submitted in three (03) copies to reach the office of the undersigned in sealed cover not later than 02.00 pm and will be opened on 03.00 pm on same date.

The intended contractor / firm can apply either in consortium or as a single entity. The consortium consisting more than three (03) firms shall not be eligible for participation. If
